Family Involvement...It's Important!



Policy Council

The Policy Council is an elected body of parents and community representatives who participate in all important decisions affecting the local Head Start program. These decisions include personnel, planning and budget.

Family Fun Nights

Held monthly in each county; children share an activity with mom and dad and parents are given information about the program and upcoming opportunities.

Social Committees

Help the agency staff plan winter celebrations and end-of-school celebrations for the children.

Advisory Boards

Parents participate in Health Advisory Boards and in School Readiness each year.

In addition to parent involvement, children are more likely to achieve and maintain educational gains if parents or caretakers can meet the needs of the entire family.

Self-Assessment

Families are asked to help us analyze the agency's strengths and weaknesses on a yearly basis.

Parent-Teacher Conferences

Each Head Start family is offered at least two parent-teacher conferences and two HV's (or more if needed) per year! Teachers review the child's progress and help parents set educational goals that are appropriate for the child.

School Transition

Early Head Start implements strategies and practices to support successful transitions for children and their families transitioning into Head Start. Head Start implements transition strategies to support a successful transition for children and their families transitioning into Kindergarten.

Parent Surveys

Done once a year to study parents needs and level of satisfaction with the agency.

Family Service Workers (Head Start)

Head Start staff meet with parents 3 or more times a year to set goals, share the child's successes, and talk about child development, health, nutrition, child care, budgeting, and transitioning to kindergarten.

Home Visitor/Family Support Worker (Early Head Start)

Home visitation staff meet parents weekly on the home based side and quarterly on the childcare side. FSW's also complete a quarterly parent provider visit and a monthly childcare visit. Parents are the key to success in these visits.

Federal Program Re-

Focus Area One is an opportunity for grantees to discuss their program design, management, and governance structure. In addition, this focus area is designed to develop an understanding of each grantee's foundation for program services. Grantees will describe approaches to staffing structure, program design, education, health services, family services, fiscal infrastructure, and program governance.

Budgetary Expendi-

Our approved budget calls for 65-70% of all our expenditures to go for staff salaries and benefits, to pay our staff which now numbers more than 70. The work we do is a labor-intensive work, with the adult-to-child ratio a major factor in how well children learn. Although the State of Kansas allows for a oneadult-for-every-ten-kids ratio in the programs it licenses (programs like ours), we maintain an average of one-adult-forevery-four-to-seven-children ratio in our classrooms.

Preparation for Transition



Children make the transition into preschool from home visiting or from preschool to kindergarten more successfully when their home visitors, teachers, schools and families prepare it together, and all parties connect. By coordinating transition efforts, preschool and elementary programs can help children maintain and maximize the gains they made in preschool.

Head Start and Early Head Start use a collaborative approach to transitions. We include the families and schools to assist in preparing everyone involved for whatever transition the families may face.





Our program has a School Readiness Committee that meets at least twice a year to discuss the goals, how they tie into the Galileo, Frog Street, Growing Great Kids, Galileo Assessment and the direction the program should go in that area. Annually, we meet with all the local school districts, typically after their Kindergarten Screenings, and share information regarding the children that will be transitioning from Head Start to Kindergarten. Early Head Start home visitors discuss with parents the options available to their children when the child reached 2.5 years of age. All medical files, ASQ, and ASQ-SE's are sent to Head Start when the child transitions.
